


Union Notes – February 18, 2021

The Safe Framework for Restarting In-Person Instruction



When we look at our [bargaining platform](#), new information on vaccines, and the [CLASSES](#) report, it is clear that there are three key pillars for reopening that keep educators, our students and our communities safe:

- **Lower Community Case Rates** - Lower case rates in our communities are essential to safely reopening. San Diego needs to be in the red tier or better.
- **Onsite Mitigations** - Testing, proper ventilation, masks, full & proper PPE, hand sanitizing supplies and stations, reducing occupant capacity of rooms, and other mitigation measures are critical for a successful phased reopening.
- **Vaccine Availability** - All employees must have the opportunity to complete the full vaccination cycle (first and second doses, and reach peak immunity).

State Testing Waiver Hearing

Previously, California was turned down for a testing waiver from the Federal Dept of Education. The state responded with a modified short form CAASPP test. Now that there is a new administration, there may be an opportunity to receive the testing waiver.

The CA State Board of Education will be meeting February 24. One of the agenda items ([Item 02](#)) is the pursuit of a federal waiver for testing.

If you are interested in addressing the board as a concerned citizen, they accept one minute commentary via phone. Directions on how to call in are on the [website](#). Since the meeting is scheduled for 8:30 am, it may be easier to submit written comment.

According to the [website](#), the public is highly encouraged to submit written comments to the SBE members in advance for their prior consideration. In order to help ensure that board members have sufficient time to review all comments, please submit comments **by noon on Monday, February 22, 2021**.
