Special Education Update

Yesterday, a team of SDEA special education staff met with the District to share our concerns about the recently released guidelines for implementation of special education services and supports during the 2020-2021 school year. The meeting was productive and the District agreed to incorporate our feedback into the newest version of the special education guidelines and supporting documents that were updated at 1 pm today. The priorities that we conveyed are (1) the guidelines must conform with the protections enshrined in our July 30th Online Learning Agreement with the District, (2) parents must receive information that is clear and conforms with the Online Learning Agreement, and (3) the sustainable workload of special education staff must be a primary consideration when developing district policy. SDEA and District special education leadership agreed to continue collaborating on determining best practices for meeting the needs of students with IEPs during this crisis.

Starting this school year, Mild/Moderate teachers' caseloads are capped at no more than 20 students when the following criteria are met:

- 1. Mild/Moderate teachers' caseloads at the site are balanced. In other words, in order for this hard cap to be triggered you can't have one teacher with 18 students and another with 22 students.
- 2. The caseload of 20 has been exceeded for 10 or more workdays.

Please let your administration know if you meet the above criteria on September 15th. According to our contract, the District is required to give your site an additional allocation of Mild/Moderate teacher time to bring the caseload under 20.
