CONDITIONS OF RECORD

The amount so deducted shall be transmitted to the organization designated on the other side of this card; and upon remitting the deduction, the District shall have fulfilled its entire obligation and shall be held harmless in the event of defalcation on the part of the designated organization or any of its employees.

This authorization must be received in the Personnel Operations department by the first working day of the month in which the deduction is to become effective and will remain in force until cancelled by me in writing.

The San Diego Education Association/Political Action Committee (SDEA/PAC) collects contributions from Association members and uses these funds to help elect friends of education at the local level. The SDEA/PAC is a General Purpose County political action committee. Although SDEA/PAC requests an annual contribution of \$8, this is only a suggestion. A member may contribute more or less than the amount suggested or may refuse to make any contribution, and this will not affect his or her membership status, rights, or benefits in NEA, CTA or SDEA. A copy of the NEA Fund for Children and Public Education report is filed with the Federal Election Commission and is available for purchase from the Federal Election Commission, Washington, D.C. 20460.
