YOUR ORGANIZATION

SDEA/CTA/NEA-Retired and its members is a strong voice for education retirees in state and local policymaking. The organization works hard to protect and maintain your benefits:

- Worlking to repeal the unfair Government Pension Offset (GPO) and Windfall Elimination Provision (WEP).
- Opposing efforts to privatize Social Security.
- Working to strengthen Medicare.
- Advocating for Defined Benefit Pension Plans
- Protect and enhance State Teachers pension plans that come under attack.

SDEA/CTA/NEA-Retired devotes 100% of its time and resources to serve the combined interests of retired teachers, educatiors, college & university professors and educatin al support personnel.

Retired members elect delegates from each region of the state to represent retirees' special needs on CTA's governing body, the State Council of Educaiton. Retired members may also form local chapters, drawing members

from a CTA chapter, UniServ or Service Center Council area. SDEA/CTA/NEA-Retired is an active affiliate of NEA-Retired, and sends delegates to the annual NEA Representative Assembly each summer.

Membership in SDEA/CTA/NEA-Retired is unified, that is, when joining you will join SDEA/CTA/NEA-Retired.

BE A MEMBER -YOUR VOICE WILL BE HEARD

SDEA/CTA/NEA-Retired is the state's most active and influential lobby for education issues, including retirement and health concerns. Over the last several years, CTA advocates have successfully lobbied to increase CALSTRS benefits for current members. These funds have been used to increase the buying power of retirees, teacher retention and enhanced pension benefits. SDEA/CTA/NEA-Retired monitors all CALSTRS meetings, presenting the views of its members to the CALSTRS Board of Directors. Working with NEA, CTA/NEA-Retired maintains a constant vigil on federal legislation that may affect retirement benefits. Retired members are kept informed through the Retiree Advocate and website focusing on retiree needs and interests.

PRE-RETIRED SUBSCRIBERS

Members of CTA are eligible to become Pre-Retired Subscribers prior to retirement. By paying life membership dues of \$470.00, members become eligible to receive the benefits and services of CTA/NEA-Retired immediately upon retirement. Many active members take advantage of this provision in order to ensure their retired membership status upon retirement, and with no further payment of SDEA/CTA/NEA-Retiree dues, are able to pay for a lifetime of membership at a time when their income may be greater.

BENEFITS FOR SDEA/CTA/NEA-RETIRED MEMBERS

The benefits of membership in SDEA/CTA/NEA-Retired begin as soon as you begin your retirement. As a member of SDEA/CTA/NEA-Retired, you are eligible for legal services in the event you have problems with your retirement status. This consultation regarding your retirement rights is provided through the CTA Group Legal Services program.

By continuing your membership in SDEA/CTA/NEA-Retired, you are also eligible to continue to participate in the many economic benefits available to active members. The following is a partial list of those benefits:

- Life Insurance (Must be participating in this at the time of retirement and continue without interruption/Lifetime membership required.)
- Automobile insurance
- Homeowners insurance
- Credit Union services
- 1 Million dolalrs liability

An enrollment form is included on this brochure. There are several methods for paying your SDEA/CTA/NEA-Retired dues:

- Pay a one-time Lifetime dues amount of \$470.00.
- Annual dues are \$57.00.
 - Payable to SDEA/CTA/NEA-Retired in full; or
 - Monthly amount (\$4.75) deducted from your monthly CALSTRS Pension check. If you elect to have a deduction from your CALSTRS check, you must include your Social Security number and be sure to sign at the bottom of the enrollment form.
 - Pre-retired Subscribers may join by paying a one-time Life membership Dues of \$470.00.
