



A DOWN PAYMENT ON TRANSFORMATIONAL CHANGE

As you know, SDEA is currently engaged in bargaining with SDUSD. The past 14 months have been spent primarily bargaining protections for union members around the impacts and effects of the pandemic. This has meant that we have had to pause bargaining over our main contract, which has been open since June 30, 2020.

In early December 2019, SDEA members across the District took part in an unprecedented action. Members at nearly 130 sites and programs reviewed and discussed our proposed bargaining platform before holding a secret ballot vote to support or reject the platform. SDEA members voted overwhelmingly to support the SDEA bargaining platform as we entered into negotiations with the District in January of 2020.

Our <u>SDEA Bargaining Platform</u> lays out a clear path to improving the conditions of teaching and learning and calls on SDUSD to direct considerable resources to our classrooms where they are needed most.

SDEA's <u>recent proposal</u> to SDUSD aims both to turn the bargaining platform into a reality beginning this fall and to serve as a down payment on larger and longer term improvements we can make once we return to the bargaining table for our longer contract extension next school year.

In years past, SDEA has had to fight with SDUSD over our share of a district budget that always seemed to be in a severe deficit. This year, due to unprecedented state and federal funding, budget deficits are not an issue.

Though next school year is already close at hand, our Bargaining Team believes we can and should make needed improvements now and set the stage for greater investment in the schools our students deserve when we return to the bargaining table in early 2022.

One challenge facing SDUSD is that this influx of state and federal funding is primarily one-time monies with spending deadlines. We will have to push SDUSD to make prudent, yet creative, decisions around spending or we will be right back where we were a year ago, searching for resources to support our students and schools. That push is going to take collective power on the part of every member of SDEA. We must use the upcoming school year to rebuild our power, starting at every site. We must reestablish relationships with each other and with parents and community in our fight for the schools our students deserve.

We have started the work of rebuilding those relationships with the Statewide Bargaining Survey presented to ARs and CRs at the May Rep Council. We asked those site reps to have conversations with all members at the site or program to gather input on issues that members felt were important to fight for in collaboration with our statewide coalition. Please take a few minutes to complete the <u>survey</u> and share your priorities. As we shared in the <u>May Advocate</u>, this survey will help us put together a statewide platform that we can unite around, fight for, and win!
