Clean sweep: SDEA wins on every race

SDEA members have a lot to be thankful for going into Thanksgiving Break, and it is a direct result of our hard work on the fall election campaign! Thanks to SDEA members and our fellow educators and union members across the state, we succeeded in passing Proposition 30 and defeating Proposition 32. Prop. 30's passage will stabilize school funding, protect class sizes and important educational programs, help ensure that educators are compensated at the rates we deserve, and protect our jobs. Prop. 32's defeat will ensure that educators and other middle class citizens will continue to have a voice in California's political process. Prop. 32's failure is crucial to our future efforts to campaign and win on the issues that matter to us, to our students and to our families

SDEA members' efforts also pushed several other important ballot measures and candidates over the finish line to victory. The passage of SDUSD school bond Proposition Z will not only fund infrastructure and technology improvements in our District, but will free up general fund monies. This will further protect our jobs and our classrooms locally.

We also succeeded in electing School Board members who have pledged to protect public education in San Diego. Both of the candidates that SDEA

endorsed for School Board, Marne Foster and John Lee Evans were victorious Richard Barrera was also reelected. The three of them join education ally Kevin Beiser on the SDUSD School Board, solidifying a fourvote, pro-education majority on our five-member School Board.

SDEA members campaigned for City of San Diego Mayor-elect Bob Filner. This is the first time our union endorsed a mayoral candidate. Filner is a long-time educator ally. He stood at our side at rallies protesting layoffs and funding cuts, and will continue to be a champion for our schools.

How did all of this happen? SDEA members made it happen. Since our schools opened their doors this fall, members have worked tirelessly to ensure that our schools have the funding and leadership that our students deserve. SDEA member efforts ran the gamut from acts as simple as holding site union meetings to educate ourselves about the issues, to hitting the streets to knock on doors and bring the community along with us—and everything in between. We passed out flyers to parents. We rallied. We phone banked. We got creative with Back to School nights, media events, and Cluster-wide organizing efforts. And we won!






SDEA is victorious, but challenges still ahead

WOW, SDEA rocks! We have to thank SDEA members who precinct walked and phone banked. We know many of you spent weekends knocking on doors and explaining the propositions to parent and community members. We also have to thank the Central Labor Council/AFL-CIO and the many other labor unions who phone banked with us and made passing Proposition 30 and defeating Proposition 32 possible. This is a great example of what we can do when we come together and work toward a common goal. While working at voting polls, we had many voters thank the educators for what they did in June to keep educators in the classrooms and class sizes down. This was their way of thanking educators and saying to Sacramento that it is time to fund public education. We should also be thankful for the leadership we have in Governor Jerry Brown (see cover) and State Superintendent Tom Torlakson (pictured here with President Bill Freeman at PHHS), who are committed to supporting education.

The passage of Prop. 30 does not mean that we will have it easy. We will still have to fight to maintain our contractual rights and to educate the District on what's best for our students. We now have to start

the preparation for negotiations in 2014. However, it is time to come together start working Community School Reform, developing short and long term strategic plans, and organizing a



communications committee that allows members to decide what information is shared with members. Bayview Terrace, Encanto protect 5-year evals.

Members at Bayview Terrace and Encanto Elementaries are enjoying the fruits of their labor and want you to, as well! Members at both schools filed grievances after their principals announced that no one would get an extended evaluation cycle of up to five years, despite their eligibility. While administrators can deny individual requests for an extended cycle, these "blanket" denials violate our contract. Shortly before the issue was set to go before an arbitrator for each grievance, members reached settlement agreements with the District. The District acknowledged that such "blanket denials" violate members' rights. The District acknowledged that the administrator is obligated to consider each request for an extended evaluation on an individual basis, and must respond swiftly enough to excuse the member from evaluation in the year of the request. These agreements set a standard for all SDEA members to rely on! Every eligible full-time Encanto and Bayview Terrace educator also received an extended evaluation cycle as part of the settlements.
