# **Bargaining Input Sessions: 129 sites and counting**

SDEA is three-quarters of the way towards reaching the 100% goal of all sites and programs conducting a Bargaining Input Session. As of publication, 129 Bargaining Input Sessions have been completed or are scheduled to be conducted prior to the commencement of the winter break. These meetings not only provide members a venue to share input, but afford members the opportunity to discuss the

importance of being united in bargaining for our new contract.

**SDEA** Bargaining Commission and bargaining team will now begin the process of reviewing and analyzing the input collected from the membership in order to determine bargaining priorities. Priorities will strategically be presented to the Rep. Council and membership in January 2014, and all of us will be part of the organizing efforts to support the bargaining campaign.

It is not too late for your school to conduct a Bargaining Input Session. SDEA Field Organizers continuing to reach out to Association Representatives (ARs) schedule the remaining meetings. If your site has not yet had a chance to share your input for the upcoming bargaining campaign, contract your site AR to help

schedule your site's meeting.

Bargaining Input Sessions have been the first step in our union's campaign to achieve fair and strong contract for 2014-15. But they cannot be the last if we want to the things we've prioritized to become a reality in our next contract. In the coming year, the strength of our union contract will be determined by the strength of our collective voice!



# New year, new challenges, new optimism

Over the past year, the promise of Prop. 30 was realized as the darkest days of budget cuts were finally put behind us and educators finally experienced the end of a school year without the threat of layoffs. Increases to state funding from Prop. 30 also put us on track for full salary restoration and the return of all 180 instructional days.

Beyond our District there has been steady progress in school funding across the state, and the California Legislative Analyst's Office recently reported that "the state's budgetary condition is stronger than at any point in the past decade."

It truly feels like one of the most devastating eras for public education in California is finally over. However, the coming year will bring new challenges in addition to an optimistic future.

Despite new funding to reduce elementary class size, our District reduced teachers and raised class sizes in primary grades—a move that potentially jeopardizes \$22 million in state funding.

The implementation of the Common Core State Standards will present challenges to students and educators alike. Our workload language will be tested, as well as our ability to work with the District while holding them accountable to provide necessary support and resources needed to make Common Core work for our schools.

With each future challenge, we will continue to take a long view to plan and implement what is in the best interests of all members with a vision that promotes the best working conditions for the membership. When joined by the collective voice of all 7,000 SDEA members we can continue to provide a strong public education for our students!

These conversations not only help us take the pulse of our communities on issues that matter, but also help us identity areas of common group where educators, parents and community members can organize together to improve public education.



### Focus on Health: Depression Awareness

### **What is Depression?**

Depression is different from normal sadness. It can engulf your daily life, interfering with your ability to work, study, eat, sleep, and have fun.

Some people describe depression as "living in a black hole" or having a feeling of impending doom. However, some depressed people don't feel sad at all—they may feel lifeless, empty, and apathetic. Other people may feel angry, aggressive, or restless.

### Signs and symptoms of depression include:

- · Feelings of helplessness and hopelessness
- Loss of interest in daily activities
- Appetite or weight changes (Significant weight loss or weight gain—a change of more than 5% of body weight in a month.)
- Sleep changes (Either insomnia, especially waking in the early hours of the morning, or oversleeping.)
- Anger or irritability
- Loss of energy

- Self-loathing (You harshly criticize yourself for perceived faults and mistakes.)
- Reckless behavior (Such as substance abuse, compulsive gambling, reckless driving, or dangerous sports.)
- Concentration problems
- Unexplained aches and pains (Increase in physical complaints such as headaches, back pain, aching muscles, and stomach pain.)
