SDUSD requested four more bargaining dates, which is a good sign—but only if what the District brings to the table accomplishes our L.E.A.R.N. goals. # Are we ready to face the new year?

We hope you had a restful Thanksgiving break. It is hard to believe we are already in December and will soon be welcoming in a new year. We have had a busy and challenging first few months of the school year, but in typical SDEA fashion, members have risen to meet those challenges head on-challenges such as having to deal with the repercussions that come from the District issuing layoff notices to over 900 of our fellow educators. This was an ill-advised decision that brought about both fear and distrust in the District's vision for the future of San Diego's educators and students. District budget cuts have resulted in reductions to the level of supports and services that our students have come to depend on, not only so they may be successful in the classroom, but have the best possible chance of success in life as well.

In the face of continuous adversity, SDEA members have chosen to step up and commit to fighting for the schools our students and local communities deserve. We have committed to fighting for a L.E.A.R.N. union contract that calls for the District to make our students and classrooms a priority. When members speak with one voice, we have the collective strength to ensure that resources are being directed to our students and schools.

The start of the school year also marked the launch of the first wave of SDEA's L.E.A.R.N campaign. In a matter of three months, over 150 school sites conducted site meetings, over 2,500 parents and educators signed petitions supporting the L.E.A.R.N campaign, and hundreds of rank and file members signed up to mobilize their school sites by becoming members of their site's CAT (Contract

Action Team). All of the amazing efforts made by members at each school site culminated in educators from over 130 school sites taking to the streets on Nov. 8 as part of a District-wide day of solidarity and call to action. Members picketed in front of our school sites before and after school, demanding that the School Board and Superintendent come to an agreement on a fair and equitable contract NOW!

With every passing day, momentum builds as members prepare ourselves to face a new reality, both as educators and union members alike. Members are organizing to meet the challenges that threaten us at all levels, whether it be threats at the federal level from a Secretary of Education who is actively working to defund public schools so they may be privatized, or the threat of the Supreme Court that will most certainly overturn previous Court rulings that have acknowledged that every public employee who enjoys the benefits and protections of a union contract should pay their fair share, and contribute. No matter the threat, the best response and greatest weapon against those who seek to dismantle both the union movement and public education is ORGANIZING!

So, as we bring the calendar year to an end and take time to celebrate the holidays with our loved ones, we would like to say thank you! Thank you for all you are doing to fight for a strong union contract, and for all that you will do upon your return. Together we are stronger, and together we will build the schools our students deserve.




