"all hands on deck" for SDEA members to protect our schools at the bargaining table and beyond. With nearly 100 BIS scheduled or held so far, SDEA members have more than tripled contributions to our local Political Action Committee, and more than 50 members have volunteered for a new SDEA leadership role.

It's working. Let's keep it up!

SDEA members have been very busy becoming more active in our union and the community since the beginning of 2017.

On Jan. 16, an SDEA contingent marched in the Martin Luther King Day March to once again stand up for what Dr. King marched for many years ago. Dr. King died while fighting for public employee unions, as well as the poor and jobless. He also died leaving racial injustice as a front and center topic for years to come.

Our educators marched this year to send a message to ALL elected officials that they will be held accountable in the areas of workers' rights and an end to the school-to-prison pipeline.

On Jan. 21, roughly 75 SDEA members marched in the San Diego Women's March to stand in solidarity with the Women's March on Washington, D.C. Individuals across our nation and across the world marched for human rights, civil liberties and social justice for all. Together we stood united in our respect for all people, resisting the marginalization of anyone.

Throughout the months of January and February, SDEA members have written hundreds of emails and made hundreds of phone calls to our Senators, urging them to vote no on Betsy DeVos' appointment as Secretary of Education, as well as against many others of the President's appointments. These calls and emails were part of over a million contacts

tracked by the National Education Association.

SDEA members are making a difference! At lesat two Republican Senators committed to join 48 Democratic Senators in voting against DeVos. We urge all of you to get involved in as many ways as you can. Here are a few things you can do:

- 1. Continue to call and email our California and national legislators to ensure they hear your voice as they make decisions that impact our communities.
- 2. Attend your site Bargaining Input Session (BIS) and ensure your priorities are heard in the bargaining process.
- 3. At your BIS, fill out an SDEA volunteer card and sign up to take part in an SDEA committee or other union leadership role.
- 4. Contribute to SDEA's Political Action Committee to help elect public education advocates.
- 5. Get involved in your local school community. We must all stand together, united around protecting our students, schools and communities and to make a difference. We must ALL take action!

If you wish this dues amount to remain in the SDEA general fund, contact Larry Moreno at 619-283-4411. In addition, a designated portion of CTA dues is normally allocated to the Association for Better Citizenship (ABC/CTA), a bipartisan political fund through which CTA provides financial support for education issues and CTA-endorsed candidates for local and state offices. Members who choose not to allocate a portion of their dues to the CTA/ABC, but instead want it to remain in the general fund, should complete a CTA-General Fund Allocation Form.
