SDEA Members Marched Against Gun Violence In Nationwide Action

SDEA members, family, and friends joined a nationwide march against gun violence on Saturday, June 11.

Organized by [March For Our Lives](#), a youth-led movement founded in the days following the February 2018 shooting at Marjory Stoneman Douglas High School, marches took place in hundreds of cities across the US, [including San Diego](#). Did you know the average student loan borrower owes over \$38,000? In this workshop you'll learn about the benefits and requirements of the three loan forgiveness programs from the U.S. Department of Education.

You'll also learn about the *NEA Student Debt Navigator*, which is a tool to help union members analyze their student loans. In addition, if you've been denied Public Service Loan Forgiveness (PSLF), we'll discuss the recently announced expansion and review of the program and explain the process to submit the PSLF Waiver. Secondary Class Size and Caseload Overage Agreements

We have reached grievance settlements for both secondary class size and M/M & M/S caseload overages for the 2021-2022 school year.

In both agreements, eligible unit members will get paid one (1) hour per student per week over caseload/class size retroactive to October 1, 2021 and through the end of the school year.
