

Minimum \$0.01 deposit to open account. The credit union will distribute the balance of the account from the \$2000 July via ACH to transfer into a CCU account. Proof of employment at a qualified California public or private school is required. APY = Annual Percentage Yield. Rates are subject to change after the account is opened. APY is accurate as of the last dividend declaration date. Dividends are on balances \$100+. Fees may reduce earnings on the account.
